

NOLA MONEYONNAISE COMPETITION

("Competition")

TERMS AND CONDITIONS

The promoter is RCL Group Services Proprietary Limited and Colony Campaigns Proprietary Limited, which is contracted to promote this Competition (collectively, the "**Promoter**").

Any persons entering or participating in this Competition ("**Participant**") accept and agree that by entering this Competition they have had an opportunity to read and consider these Terms and Conditions and that they are bound by these Terms and Conditions.

1. What is the Prize

1.1. A Participant stands a chance of winning a share of R1,307,000.00 (one million three hundred and seven thousand Rand) in prizes as follows:

1.1.3.2. Week 2: 2 (two) cash prizes valued at R20,000.00 (twenty thousand Rand) each;

1.1.3.3. Week 3: 5 (five) cash prizes valued at R10,000.00 (ten thousand Rand) each;

1.1.3.4. Week 4: 4 (four) cash prizes valued at R15,000.00 (fifteen thousand Rand) each;

1.1.3.5. Week 5: 2 (two) cash prizes valued at R10,000.00 (ten thousand Rand) each;

1.1.3.6. Week 6: 2 (two) cash prizes valued at R15,000.00 (fifteen thousand Rand) each;

1.1.3.7. Week 7: 2 (two) cash prizes valued at R20,000.00 (twenty thousand Rand) each;

1.1.3.8. Week 8: 2 (two) cash prizes valued at R10,000.00 (ten thousand Rand) each;

- 1.1.3.9. Week 9: 5 (five) cash prizes valued at R5,000.00 (five thousand Rand) each;
- 1.1.3.10. Week 10: 2 (two) cash prizes valued at R10,000.00 (ten thousand Rand) each;
- 1.1.3.11. Week 11: 1 (one) cash prize valued at R5,000.00 (five thousand Rand);
- 1.1.3.12. Week 12: 3 (three) cash prizes valued at R10,000 (ten thousand Rand) each; and
- 1.1.3.13. Week 13: 2 (two) cash prizes valued at R50,000.00 (fifty thousand Rand) each

(collectively, "**Cash Prize**"),

and, if the Participant participates in the in-store digital spin & win promotion ("**Spin & Win**") at a participating store listed in "Annexure A" ("**Participating Store**") a chance of winning:

- 1.1.4. a share of 11,150 (eleven thousand one hundred and fifty) airtime bundles with no expiry date in the following denominations:
 - 1.1.4.1. 6,000 (six thousand) airtime bundles valued at R10.00 (ten Rand) each;
 - 1.1.4.2. 3,000 (three thousand) airtime bundles valued at R20.00 (twenty Rand) each;
 - 1.1.4.3. 2,150 (two thousand one hundred and fifty) airtime bundles valued at R30.00 (thirty Rand) each (collectively, "**Spin & Win Airtime Prize**"); and/or
- 1.1.5. a share of 1,450 (one thousand four hundred and fifty) eVouchers redeemable at the relevant Participating Store at which the Participant participates in the Spin & Win for a period of 3 (three) years from the date of issue in the following denominations:
 - 1.1.5.1. 600 (six hundred) eVouchers valued at R50.00 (fifty Rand) each;

 - 1.1.5.3. 325 (three hundred and twenty-five) eVouchers valued at R200.00 (two hundred Rand) each (collectively, "**Spin & Win Voucher Prize**"); and/or
- 1.1.6. a share of 225 (two hundred and twenty-five) 2400W 8L air fryers valued at R1,000.00 (one thousand Rand) each ("**Spin & Win Air Fryer Prize**"). Only 1 (one) Spin & Win Air Fryer Prize will be allocated to each Participating Store for the Competition period.

(collectively, the "**Prize**").

- 1.2. The Prize is not transferrable and may not be exchanged for cash or any other items. The Promoter reserves the right to substitute the Prize/s with any other prize of comparable commercial value.

2. Who can participate

- 2.1. Any person in South Africa who is 18 (eighteen) years or older may participate in this Competition provided he/she is in possession of a valid South African identity document, passport, or documentary proof of South African residency and, for purposes of the Airtime Prize, Voucher Prize, Spin & Win Airtime Prize and Spin & Win Voucher Prize, has a **registered**

prepaid cell phone in South Africa.

- 2.2. No director, member, partner, employee or agent of, or consultant to the Promoter, any person who directly or indirectly controls or is controlled by the Promoter or any supplier of goods or services in connection with the Promotion, or the spouses, life partners, business partners or immediate family members may enter this Competition.

3. How to Participate

- 3.1. To enter this Competition, Participants must:

- 3.1.1. Buy any Nola Mayonnaise product ("**Participating Product**") from any retail or wholesale store that sells the Participating Product nationwide, and keep the proof of purchase (till slip);
- 3.1.2. Scan the QR code that appears either on the pack of any Participating Product or on any Nola promotional Competition advertisement, or send a WhatsApp message saying "NOLA" to 071-370-7149 or visit <https://clny.co/nola>. For purposes of the Airtime Prize, Voucher Prize, Spin & Win Airtime Prize and Spin & Win Voucher Prize this must be done with the Participant's **registered prepaid** cell phone;
- 3.1.3. Follow the prompts and answer the questions; and
- 3.1.4. Upload an image of their full proof of purchase (till slip) reflecting the date and the purchase of any Participating Product.

- 3.2. To enter the Spin & Win at a Participating Store, Participants must:

- 3.2.1. Follow all the steps set out in clause 3.1 above, provided that the Participating Product must be purchased from one of the Participating Stores and must be purchased on the same day or within the same week that the Participant is entering the Spin & Win (as the Spin & Win will only run on Fridays and Saturdays);
- 3.2.2. Show the final message received after completing the WhatsApp journey in clause 3.1 to the in-store promoter at the Participating Store. - 3.2.3. Show their original full proof of purchase (till slip) to the in-store promoter at the Participating Store. The original full proof of purchase (till slip) must be dated the same day or within the same week that the Participant is entering the Spin & Win (as the Spin & Win will only run on Fridays and Saturdays). Participants must keep their original proof of purchase (till slip), which may need to be provided to the Promoter if the Participant is a provisional winner(s) and/or winner(s) in the Competition; and

- 3.10. Entries which are unclear, illegible or contain errors will be declared invalid.
- 3.11. **The Promoter shall not be responsible for any lost, damaged or delayed entries for any reason whatsoever, and proof of sending will not be accepted as proof of receipt by the Promoter. The Promoter is not liable for any technical failures affecting the participation and/or Prize redemption process of this Competition.**
- 3.12. In the event that entry into this Competition is contingent on the Participant entering any website or social media page or application, the Participant hereby acknowledges that any and all costs associated with the required internet connection will not constitute a cost of entering into this Competition and shall be borne solely by the Participant.

4. Personal Information

- 4.1. By entering this Competition, the Participant consents to the collection, use, storage, disclosure, processing and further processing of his/her personal information (the Participant's name, ID number, cellphone number, address, personal preferences, and other personal information the Participant provides when entering and participating in this Competition) by the Promoter.
- 4.2. The purposes for processing personal information is to: (i) conduct this Competition; (ii) facilitate the Participant's participation in the Competition; (iii) communicate with the Participant and send direct marketing communication on Nola Mayonnaise and similar products via SMS and email and (iv) for market and product research.
- 4.3. Should the Participant object to the processing of his/her personal information and/or receipt of direct marketing, the Participant should send an e-mail to RCLConsumerCare@rclfoods.com.
- 4.4. **By posting any content, images, or comments on any of the Promoter's public and/or social media platforms, a Participant consents to and gives the Promoter a world-wide royalty free licence to reproduce, modify, adapt and publish such content, images or comments for the purposes of promoting the Promoter's products and/or services.**

5. Indemnity

By entering this Competition, the Participant unconditionally and irrevocably indemnifies and holds harmless the Promoter, as well as its holding company, its subsidiaries and any subsidiaries of its holding company, and their successors and assigns, directors, employees, agents or consultants against all and any losses, claims, proceeding, actions, damages, (direct, consequential or otherwise) liability, demands, expenses, legal costs (on an attorney and own client basis) howsoever arising out of, based upon, or in connection with (directly or indirectly) the Participant's participation in the Competition and the Prize/s.

6. Duration

- 6.1. This Competition runs from 1 October 2025 and closes at 23:59pm on 31 December 2025

("Closing Date"). If a Participant wants to participate in the Spin & Win, the Spin & Win will only run on Fridays and Saturdays from 4 October 2025 to 13 December 2025 at the Participating Stores ("Closing Date"). Any entries received after the Closing Date will not be considered.

- 6.2. The Promoter reserves the right to reasonably extend, shorten, suspend the time period of this Competition or terminate the Competition for technical, commercial, and/or operational reasons, or for reasons beyond its control. **This Competition, Prize and Terms and Conditions may be reasonably amended by the Promoter, at any time during the Competition. In such event, all Participants waive any rights that they may have or purport to have in terms of this Competition and acknowledge that they shall have no recourse against the Promoter whatsoever.**

7. Results

- 7.1. The provisional winners will be determined as follows:

7.1.1. Airtime Prize:

- 7.1.1.1. The provisional winner(s) of the Airtime Prize will be selected using an electronic random picker during the Competition period.
- 7.1.1.2. The Airtime Prize will be automatically awarded and loaded electronically onto the registered prepaid cell phone(s) of the winner(s), which will be the same cell phone number used to enter the Competition. The Airtime Prize will be electronically loaded instantly once the winner(s) is determined, however due to possible network delivery delays, it may take up to 2 (two) working days for the Airtime Prize to reflect.

7.1.2. Voucher Prize:

- 7.1.2.1. The provisional winner(s) of the Voucher Prize will be selected by a random draw weekly during the Competition period.
- 7.1.2.2. A code for the Voucher Prize will be sent via SMS to the registered prepaid cell phone(s) of the winner(s), which will be the same cell phone number used to enter the Competition. The code for the Voucher Prize will be sent via SMS within 2 (two) working days of the date on which the winner(s) is verified.

7.1.3. Cash Prize:

- 7.1.3.1. The provisional winner(s) of the Cash Prize will be selected by a random draw weekly during the Competition period as set out in clause 1.1.3.

7.1.4. Spin & Win Airtime Prize:

- 7.1.4.1. The provisional winner(s) of the Spin & Win Airtime Prize will be determined by Participants following all entry steps in clauses 3.1 and 3.2 and spinning the digital wheel at a Participating Store.
- 7.1.4.2. The Spin & Win Airtime Prize will be loaded electronically onto the registered prepaid cell phone(s) of the winner(s), which will be the same cell phone number used to enter the Competition. The Spin & Win Airtime Prize will be electronically loaded instantly once the winner(s) is determined, however due to possible network delivery delays, it may take up to 2 (two) working days for the Spin & Win Airtime Prize to reflect.

7.1.5. Spin & Win Voucher Prize:

- 7.1.5.1. The provisional winner(s) of the Spin & Win Voucher Prize will be

determined by Participants following all entry steps in clauses 3.1 and 3.2 and spinning the digital wheel at a Participating Store.

- 7.1.5.2. A code for the Spin & Win Voucher Prize will be sent via SMS to the registered prepaid cell phone(s) of the winner(s), which will be the same cell phone number used to enter the Competition. The code for the Spin & Win Voucher Prize will be sent instantly once the winner(s) is determined, however due to possible network delivery delays, it may take up to 2 (two) working days for the code for the Spin & Win Voucher Prize to reflect.

7.1.6. Spin & Win Air Fryer Prize:

- 7.1.6.1. The provisional winner(s) of the Spin & Win Air Fryer Prize will be determined by Participants following all entry steps in clauses 3.1 and 3.2 and spinning the digital wheel at a Participating Store.
- 7.1.6.2. The Spin & Win Air Fryer Prize will be given away to the winner(s) instantly at the Spin & Win activations taking place in the Participating Stores during the Competition period.

- 7.2. Separate weekly draws will be held for the Voucher Prize and the Cash Prize. Participants will only stand a chance to win either a Voucher Prize or a Cash Prize in the week of the Competition in which they entered. Each week of the Competition period will have its own separate pool of entries and Participants' entries will accordingly not be considered in subsequent weekly draws during the Competition period.

- 7.3. The Participant(s) selected as the provisional winner(s) of the Voucher Prize or the Cash Prize will be notified via telephone within 5 (five) working days of the date on which the provisional winner(s) is determined. The Promoter will attempt to contact the provisional winner(s) as follows:

- 7.3.1. where the provisional winner(s) has, in their participation in the Competition, provided a cell phone number, the Promoter will attempt to phone the provisional winner(s) 3 (three) times a day for 2 (two) working days calculated from the day on which the Promoter has made initial contact with the provisional winner(s); or
- 7.3.2. where the provisional winner(s) has participated in the Competition via social media, the Promoter will make contact with the provisional winner(s) via the Competition post, requesting that the provisional winner(s) contact the Promoter via direct message within 2 (two) working days calculated from the day on which the Promoter has made initial contact with the provisional winner(s); or
- 7.3.3. where the provisional winner(s) has, in their participation in the Competition, provided an e-mail address, the Promoter will attempt to e-mail the provisional winner(s) once a day for 2 (two) working days calculated from the day on which the Promoter has made initial contact with the provisional winner(s).

- 7.4. In the event that the provisional winner(s) cannot be contacted in accordance with clause 7.3 above, or their relevant details cannot be verified during this period, the Voucher Prize and/or Cash Prize will be deemed to be forfeited and the Promoter reserves the right to select another Participant in substitution.

- 7.5. The names of the winners may be published on the Promotor's website and/or social media pages.

- 7.6. The Promotor will require the Participants, provisional winner(s) and/or winner(s) to:

- 7.6.1. provide their name and identity number to enable the Promotor to verify the entry or provide a copy of documentary proof of South African residency (e.g work or study Visa);

- 7.6.2. provide their proof of purchase (till slip) to enable the Promoter to verify their entry;
- 7.6.3. sign an acknowledgment of receipt of the Prize;
- 7.6.4. provide proof of their banking details; and
- 7.6.5. where the entry includes the submission of any work eligible for copyright in terms of the Copyright Act No. 98 of 1978, as amended conclude an agreement of assignment whereby any rights which the winner may have in respect of such works are transferred to the Promoter,

should the provisional winner(s) refuse to comply with this rule for any reason then the provisional winner(s) shall be deemed to have rejected the Prize, and it shall revert to the Promoter.

- 7.7. The Promoter reserves the right to announce the name(s) of the winner publicly. The winner may be requested to attend the draw and to take part in the Promoter's publicity campaigns or to allow their photo and likenesses to be used by the Promoter for promotional purposes. The winner is, however, entitled to decline such request.
- 7.8. Where a winner consents to take part in the Promoter's publicity campaigns, they will not be entitled to any remuneration for such participation and all materials arising from such participation will be the sole property of the Promoter.

8. General

- 8.1. Prizes will only be awarded after the winner verification is successfully completed by the Promoter. Failing successful verification, the winner will be disqualified, and a back-up winner may be drawn at the discretion of the Promoter.
- 8.2. The details of the Prize, including but not limited to the colour, style, et cetera will be entirely at the Promoter's discretion.
- 8.3. The Promoter reserves the right to delete any information uploaded by a Participant which the Promoter, in its absolute discretion, believes is illegal, obscene, offensive or defamatory, or infringes the intellectual property rights of a third party, or is otherwise inappropriate for a campaign designed for mass audience entertainment.
- 8.4. Participants warrant that they have full rights to the images and/or stories and/or videos and/or till slips that they upload and that the use of the said material shall not constitute a breach of any third party's copyright or other intellectual property rights.
- 8.5. Participants agree that by participating in this Competition, they grant permission to the Promoter to take images and/or videos of their participation in this Competition, in any and all media for promotional/marketing purposes with no consideration payable to the Participants.
- 8.6. Prizes can only be delivered to addresses within South Africa. If a winner resides outside of South Africa, the winner will have to nominate an address and contact person within South Africa to receive the award on his/her behalf. The winner will be responsible for exporting the Prize across the border. The South African address provided cannot be a courier depot.
