

### **RCL FOODS YOUNG CHEFS CHALLENGE**

(this "Competition")

# **TERMS AND CONDITIONS**

The promoters are RCL FOODS Consumer (Pty) Ltd, Siqalo Foods (Pty) Ltd and South African Chefs Association, known as SA Chefs, which are contracted to promote this Competition (collectively "the Promoter").

Any persons entering or participating in this Competition ("Participant") accept and agree that by entering this Competition they have had an opportunity to read and consider these Terms and Conditions and that they are bound by these Terms and Conditions.

#### 1. WHAT IS THE PRIZE?

- 1.1 The winning team will receive R30 000.00, split equally between the 2 participants. Second place will receive R20 000.00, split equally between the 2 participants, and third place will receive R15 000.00, split equally between the participants.
- 1.2 The winning three schools will each receive hampers of RCL FOODS products to the value of R7 500.00, R5 000.00 and R2 500.00 respectively according to their positions.
- 1.3 All Regional Finalists will receive a Certificate of Participation.
- 1.4 The Prize is not transferrable and may not be exchanged for any other items. The Promoter reserves the right to substitute the prize/s with any other prize of comparable commercial value.

### 2. WHO CAN PARTICIPATE?

- 2.1 Any person who is a legal resident of South Africa who is between the ages of 18 and 25 years, and who is enrolled with a professional institution focusing on Culinary Arts or a Professional Cookery programme may participate. A participant may not be older than 25 on the date of the National Finals on 22 October 2021 in order to participate in the finals.
- 2.2 The Participant must be a fully paid up member with the South African Chefs Association and have a valid membership number.
- 2.3 No director, partner, employee or agent of, or consultant to the Promoter, any person who directly or indirectly controls or is controlled by the Promoter or any supplier of goods or services in connection with the Promotion may enter this Competition.

# 3. HOW TO PARTICIPATE

- 3.1 To enter this Competition, Participants must:
  - 3.1.1 Form a Team of 2 Participants (who meet the requirements in clause 2); and who are from the same institution, and at the same campus; and
  - 3.1.2 Complete in full the Competition Entry Form attached to these Terms and Conditions. Entries which are incomplete, unclear, illegible or contain errors will be declared invalid.

- 3.2 Participants and Teams may only enter once.
- 3.3 To enter, each Team must submit a typed recipe, costing and photograph of each of the following courses:
  - 3.3.1 Catering Main Course serving 3 pax budget R25.00 excl. VAT per plate using any 3 RCL FOODS products as compulsory ingredients;
  - 3.3.2 Restaurant Main Course serving 3 pax budget R35.00 excl. VAT per plate using Nola, Marvello and any Rainbow Chickens products as compulsory ingredients; and
  - 3.3.3 Innovation Dessert Course serving 3 pax budget R25.00 excl. VAT per plate using Marvello Margarine, Meadowland Dairy Cream Alternative, Supreme Flour and Selati Sugar, as compulsory ingredients. Participants may use Yum Yum Peanut Butter as an optional ingredient.
- 3.4 Besides the compulsory RCL FOODS and Siqalo Foods ingredients mentioned in 3.3 above, participants are encouraged to use RCL FOODS and Siqalo Foods products when preparing the submitted recipes. Ingredients provided at the competition will be from the RCL FOODS and Siqalo Foods baskets of ingredients where applicable.
- 3.5 Entries will need to be typed, costed and photographed and submitted to competitions@sachefs.co.za by no later than midnight on 31 July 2021 ("the Closing Date").
- 3.6 Entries will be judged by a panel of expert chef judges and 6 Regional Finalists will be chosen per region.
- 3.7 The Participants selected to go through to the Regional Finals will be notified via telephone and email within 5 days after the Closing Date. In the event that the Participant cannot be successfully contacted, or fails to respond to the Promoter within 24 hours, the Promoter reserves the right to select another Participant in substitution. The names of the Regional Finalists will also be published on the RCL FOODS website www.rclfoods.com. The Teams that have been entered cannot be changed, and substitutions will not be allowed. If a team Participant cannot attend the Regional or National round, then that Team will be disqualified and the next highest scoring Team from that region will go through.
- 3.8 Regional competition dates are as follows:
  - 3.8.1 KwaZulu-Natal 12 August 2021;
  - 3.8.2 Cape Town 17 August 2021;
  - 3.8.3 Free State 19 August 2021;
  - 3.8.4 Gauteng 24 August 2021; and
  - 3.8.5 Limpopo 26 August 2021.

Venues will be confirmed closer to the time.

- 3.9 **Regional Finals** Teams will cook the following:
  - 3.9.1 The submitted Restaurant Main Course to serve 3 pax within an hour, then present it to the judges for tasting. Thereafter Teams will clean down for 15 minutes.
  - 3.9.2 A Mystery Basket competition will follow where Teams will have 30 minutes to write a menu, and 1 hour and 15 minutes to prepare, cook and present a dessert course using a minimum of 4 RCL FOODS ingredients, serving 3 pax to the judges for tasting.

- 3.10 The participants selected to go through to the National Finals will be judged on the food that is prepared and presented at the Regional Finals by the participants and judged by a panel of qualified SA Chef judges, using an App designed by SA Chefs.
- 3.11 The top 2 Teams from each Regional competition will compete in the National Final competition.
- 3.12 All National Finalists will be notified via telephone and email within 7 days after the last Regional Finals date.
- 3.13 The National Finals competition will be held on 22 October 2021 at RCL FOODS Head Office, 10 The Boulevard, Westway Office Park, Westville, KwaZulu-Natal.
- 3.14 **National Finals** Teams will cook the following:
  - 3.14.1 Main Course from a Mystery Basket. Teams will have 30 minutes to write a menu and 1 hour to cook and present the Main Course to the judges for tasting. (2 x compulsory RCL FOODS Ingredients and minimum of any other 3 RCL FOODS ingredients) Thereafter Teams will clean down for 15 minutes;
  - 3.14.2 The Team will also have to bake and serve 2 different breads from a Mystery Basket; and
  - 3.14.3 The submitted Innovation Dessert will follow where Teams have to serve 3 pax, and will have 1 hour 30 minutes to cook and present the Innovation Dessert to the judges for tasting.
- 3.15 Teams must ensure that the submitted recipes that they will be cooking in the Regional and National Finals can be made within the time limits as stipulated above.
- 3.16 Directly after the National Finals have been judged, prizegiving will take place at RCL FOODS Head Office and light snacks and refreshments will be served.
- 3.17 RCL FOODS will provide flights to and from OR Tambo, Cape Town International and Bloemfontein airports to the Teams competing in the National Finals. Transport will be provided from the airport to RCL FOODS. Accommodation and transport for KwaZulu-Natal Finalists will not be provided and these Finalists will have to provide their own accommodation and transport requirements.
- 3.18 The Promoter shall not be responsible for any lost, damaged or delayed entries for any reason whatsoever, and proof of sending will not be accepted as proof of receipt by the Promoter. The Promoter is not liable for any technical failures affecting the participation and/or Prize redemption process of this Competition.
- 3.19 In the event that entry into this Competition is contingent on the Participant entering any website or social media page or application, the Participant hereby acknowledges that any and all costs associated with the required internet connection will not constitute a cost of entering into this Competition and shall be borne solely by the Participant.

### 4. PERSONAL INFORMATION

- 4.1 By entering this Competition the Participant consents to the collection, processing and further processing of his/her personal information (the Participant's name, ID number, cellphone number, address, personal preferences, and other personal information the Participant provides when entering and participating in this Competition) by the Promoter.
- 4.2 The purposes for processing personal information is to: (i) conduct this Competition; (ii) facilitate the Participant's participation in the Competition; (iii) communicate with the

Participant.

- 4.3 Should the Participant object to the processing of his/her personal information, the participant should send an e-mail to brad.kavanagh@rclfooods.com.
- 4.4 By posting any content, images, or comments on any of the Promoter's public and/or social media platform, and/or by submitting recipes, a Participant consents to and gives the Promoter a world-wide royalty free licence to reproduce, modify, adapt and publish such content, images, recipes or comments for the purposes of promoting the Promoter's products and/or services.

# 5. INDEMNITY

By entering this Competition, the Participant unconditionally and irrevocably indemnifies and holds harmless the Promoter, as well as their holding companies, their subsidiaries and any subsidiaries of their holding companies, and their successors and assigns, directors, employees, agents or consultants against all and any losses, claims, proceeding, actions, damages, (direct, consequential or otherwise) liability, demands, expenses, legal costs (on an attorney and own client basis) howsoever arising out of, based upon, or in connection with (directly or indirectly) the Participant's participation in the Competition and the Prize/s.

#### 6. DURATION

- 6.1 This Competition runs from 01 June 2021 and submissions close at midnight on 31 July 2021 ("Closing Date"). Any entries received after the Closing Date will not be considered.
- 6.2 The Promoter reserves the right to reasonably extend, shorten, suspend the time period of this Competition or terminate the Competition for technical, commercial, and/or operational reasons, or for reasons beyond its control. This Competition, Prize and Terms and Conditions may be reasonably amended by the Promoter, at any time during the Competition. In such event, all Participants waive any rights that they may have/purport to have in terms of this Competition, and acknowledge that they shall have no recourse against the Promoter whatsoever.

# 7. RESULTS

- 7.1 The winners of the National Finals on 22 October 2021 will be scored by a panel of qualified SA Chefs judges, using an App designed for judging food competitions. The results of the National Competition will be announced at the Prizegiving ceremony after the National Finals on 22 October 2021 and be made available on the RCL FOODS Website.
- 7.2 The judges' decision will be final and binding, and no correspondence will be entered into.
- 7.3 The payment of the cash Prizes will be made by EFT into the bank accounts provided by the winners within 14 days of being announced.
- 7.4 The Promotor may require the winner/s to:
  - 7.4.1 to provide their name and identity number to enable to Promotor to verify the entry;
  - 7.4.2 to sign an acknowledgment of receipt of the Prize, and indemnity; and
  - 7.4.3 where the entry includes the submission of any work eligible for copyright in terms of the Copyright Act No. 98 of 1978, as amended conclude an agreement of assignment whereby any rights which the winner may have in respect of such works are transferred to the Promoter.
- 7.5 Should the winner/s refuse to comply with this rule for any reason then the winner shall be

- deemed to have rejected the Prize, and it shall revert to the Promoter.
- 7.6 Any winner may be requested to attend the draw and announcement of the winner, to take part in the Promoter's publicity campaigns or to allow their names and likenesses to be used by the Promoter for promotional purposes. The winner is, however, entitled to decline such request.
- 7.7 Where a winner consents to take part in the Promoter's publicity campaigns, they will not be entitled to any remuneration for such participation and all materials arising from such participation will be the sole property of the Promoter.

#### 8. DISPUTES

- 8.1 Should any dispute arise in relation to these Terms and Conditions, the Promoter's decision will be final, and no correspondence shall be entered into.
